Paperwork! Paperwork! Without it, our association would be unmanageable. We need it to maintain our records for residency of 55 years and over community. When properties change hands, be it by sale or rental, there are several very important pieces of paperwork necessary to support the fact that the proper age requirements have been met. If you plan to sell your home, either yourself or your realtor must notify the HOA in order to avoid multiple delays and the possibility of interrupted sales attempts. All sales go through our property management company, so the paperwork needs to start there.

If you just need to rent or change renters, a Renter Approval Request/ Update Form and an updated Owner Certificate must be filed with the HOA. Failure to do so and allow a non-qualifying resident to move in will result in a substantial monthly fine added to your association fees. This is something that can be so easily avoided with a little bit of adherence to the rules and "paperwork".

Patriot Day is observed in the US on 9/11 to remember the lives of those who died in the 2001 terrorist attacks on the World Trade Center in NY and the <u>Pentagon</u> in Virginia and those who perished when the hijacked United Airlines Flight 93 crashed in Pennsylvania. The holiday also recognizes those who died attempting to rescue people trapped by the attacks.

By a joint resolution of the U.S. Congress on Dec. 18, 2001, September 11 was designated as Patriot Day. The resolution calls for the president of the United States to issue a yearly proclamation requesting that all U.S. flags be flown at half-staff. Further, Americans are asked to honor the dead with a moment of silence beginning at 8:46am Eastern Time, 5:46am our time. The time that the first airplane struck the World Trade Center, and to respect the ceremonies of remembrance when they are conducted.

WSK Residents, Be Aware!! Solicitors in Community

It has come to our attention that a man in his 60s, driving a white pickup truck, has aggressively been pounding on doors, asking to do car repair work. He goes by the name of Mark and will not provide any type of identification or number. Please let the Board know or call the police if this man enters your property to do work on your vehicle, which he may have caused the damage to begin with.

We have No Solicitation signs posted at both entries of our community. We are a private community and do not allow solicitors. We have every right to tell them to leave.

1. Do not open the door. 2. Do not speak to the person at the door. 3. Immediately call 911 and report what's happening at your door. 4. Do not tell the person that you're calling the police.

You don't want anyone — solicitor or otherwise — talking you into signing up for something that's not legitimate or commits you to a long-term contract you didn't want. Or worse, commits you to thousands of dollars in payments you weren't fully informed about and are unable to pay. But if those don't work, some solicitors are discouraged if you clearly post a "No Solicitors" sign near your door. All solicitors aren't dishonest. The problem is, however, that scammers who "seem to be" honest believe that seniors are easy prey. So, protect yourselves against them!

From the Vice President – Henry Kantrowitz

From now on, if you need to discuss your project with someone about architectural requests, Tom Woolslayer is now our Architectural Director. Please don't get information from fellow community members because they are not as well informed as Tom is.

A few months ago, I wrote about the shrimp industry and what harm it causes to our ocean life. Have you ever heard of long lines used for fishing? These are fishing lines that can range from a couple hundred yards to 60 miles long. Each day, there are approximately 40,000 miles of long lines put out throughout our oceans. WOW! A hook is placed approximately every six feet with either live bait or dead fish bait. This means approximately 35 million hooks are put on these long lines daily. Every 12-24 hours, the line is hauled in, and fish are harvested or thrown back into the ocean. The lines are mechanically rebaited, and set back into the water behind the vessel. These long lines target open water ocean fish like tuna and swordfish. It is estimated that almost 400 million pounds of fish are caught every day. Recent estimates indicate as much as 40 percent, or 160 million pounds, of global catch is thrown overboard. As you can see, this is unsustainable fishing.

It is better to buy fish that are caught in waters off of the coast of the United States where there are more sustainable regulations for harvesting fish.

Better yet, cut back on the amount of fish you eat to keep our oceans alive. You will consume less of the microplastics that are in most fish in the ocean.
